# Creative Time

## A Dossier

Origin. Structure. Leadership. Commissions. People. Money. Footprint --- 1973/74 to 2026

**Note.** This is a dossier, not an argument. It assembles, in one place, what is publicly recoverable about Creative Time — the New York public-art organization that has commissioned over 350 ambitious public projects since the mid-1970s — across origin, structure, leadership, commissions, people, money, and footprint. The financial spine is the IRS Form 990 series [ProPublica Nonprofit Explorer, 2026]; the institutional and project record is the organization's own site [Creative Time, 2026a], the NYU Fales archive finding aid [NYU Fales Library and Special Collections, 2026], and the public press [Wikipedia, 2026, Avenue Magazine, 2024]. Earlier source disagreements (the 1973/74 founding year, the 2015–2018 succession) have since been reconciled from primary announcements and are recorded with their reading. There is no thesis, no verdict, and no conclusion section.

## 1. ORIGIN

Creative Time was founded in New York City in the mid-1970s, as the city slid toward its fiscal crisis [Wikipedia, 2026, Avenue Magazine, 2024]. **The 1973-vs-1974 founding-year discrepancy now resolves to a definitional one, not a contradiction:** the NYU Fales finding aid dates the organization’s *establishment* to 1973 [NYU Fales Library and Special Collections, 2026], while the organization’s own “About” page and the press date the public-facing founding to 1974 [Creative Time, 2026a, Wikipedia, 2026]. The reconciling fact: in early 1974 Anita Contini, with Susan Henshaw Jones and Karin Bacon, produced *Crafts in Action* — an artist showcase staged during working hours in a vacant building at William and Nassau Streets in the Financial District [Family Style, 2024]. 1973 is the establishment/back-office date; 1974 is the first public project. The dossier records both with that reading.

The premise from the start: that ambitious contemporary art belonged in vacant, civic, and public space rather than only in galleries. Three values, still stated in the current mission, were present from the beginning: that art matters, that artists’ voices are important in shaping society, and that public spaces are places for free and creative expression [NYU Fales Library and Special Collections, 2026, Creative Time, 2026a]. The current one-line mission: “Creative Time is a public arts organization that works with artists to contribute to the dialogues, debates, and dreams of our times” [Creative Time, 2026a].

## 2. STRUCTURE

Creative Time, Inc. is a 501(c)(3) public charity headquartered at **59 East 4th Street, 6th Floor, New York, NY 10003** [Creative Time, 2026a], EIN 13-2835847, classified by the IRS under NTEE “Arts, Cultural Organizations — Multipurpose” [ProPublica Nonprofit Explorer, 2026]. It files the IRS Form 990 on a calendar-year basis (fiscal year ending December 31). Extracted 990 data is available for fiscal years 2010–2024; 2001–2009 exist on the IRS record only as scanned PDFs without extracted financials [ProPublica Nonprofit Explorer, 2026].

## 3. LEADERSHIP

Anne Pasternak’s two-decade tenure (through May 2015, when she left to become director of the Brooklyn Museum) is the long arc; under it Creative Time moved from a New York site-specific producer to an internationally cited public-art institution. **Katie Hollander** — the organization’s deputy director for roughly eight years — ran it as acting director through the nine-month interregnum, was named Executive Director in February 2016 [Creative Time, 2016], and resigned in June 2017 after about a year and a half [ARTnews, 2017];

a brief post-Hollander interim followed. **Justine Ludwig** was named Executive Director in March 2018 [Creative Time, 2018] and led through early 2026; on the FY2024 Form 990 she is the highest-compensated officer at \$243,215 plus \$12,632 other, with Amber Sasse, Head of Development, at \$105,000 plus \$10,174 [ProPublica Nonprofit Explorer, 2026]. **Jean Cooney** was announced as the next Executive Director in January 2026, with a start date of February 23, 2026, arriving from the Times Square Alliance, where she had been Director of Times Square Arts and VP of Arts & Culture since 2019 [Creative Time, 2026b].

A parallel *curatorial* thread matters as much as the executive one: the institution’s blockbuster era (late 2000s–2010s) is associated with chief curator Nato Thompson, who shaped the signature commissions and the *Living as Form* project before departing in the mid-2010s.

## 4. COMMISSIONS

Creative Time states it has commissioned and presented **over 350 public-art projects** since the mid-1970s, “in New York City, across the country, around the world — and even in outer space” [Creative Time, 2026a]. A periodized, source-anchored selection of the signature works:

Two works define the public memory. *Tribute in Light* (2001–2002) — the twin vertical beams over Lower Manhattan after September 11 — is the single most-seen Creative Time commission and the clearest case of a temporary work entering permanent civic ritual (it is restaged annually). *A Subtlety; or, the Marvelous Sugar Baby* (Kara Walker, 2014) — the monumental sugar-coated sphinx in the derelict Domino Sugar Refinery in Williamsburg — was Walker’s first large-scale public project and Creative Time’s most-discussed twenty-first-century commission [Creative Time, 2014, Wikipedia, 2026]. The *Creative Time Summit*, founded 2009, is the institution’s itinerant convening on art and social change, presented in host cities including Venice, Stockholm, Washington D.C., and Miami [Creative Time, 2026a].

## 5. PEOPLE (CURRENT)

The current staff and board are publicly listed [[Creative Time, 2026a](#)]. **Staff:** Jean Cooney (Executive Director, from Feb 2026); Yukiko Yamagata (Deputy Director); Gervais Marsh and **Celine Wong Katzman** (Associate Curators); Arantza Orengo (Senior Project Manager); Ayesha Pirbhai (Director of Advancement); Madison Shaw (Development Manager); Gloria Celeste Perez (Communications Coordinator); Buffy Sierra (Event Coordinator); Maiko Sein (Executive Assistant & Special Projects); Mark Choi (2025–26 Leonhardt Cassullo Video Fellow).

The 990-as-filed is the legally authoritative roster; the staff/board names above are the organization’s own current listing [[Creative Time, 2026a](#)].

## 6. MONEY

Creative Time’s finances are publicly recoverable through the IRS Form 990 series [[ProPublica Nonprofit Explorer, 2026](#)]. Recent fiscal years (calendar-year filings):

Creative Time runs on a low single-digit-million annual budget — notable for an institution of its visibility, and a reminder that the public footprint and the balance sheet are not proportional. Several years show expenses exceeding revenue; the FY2022 revenue peak (\$6.77M) stands against the surrounding years. Net assets have ranged from roughly \$1.3M (2019) to \$4.3M (2023). The organization’s listed major funders (2025) are the **Melton Foundation** (see the companion funder dossier [[Jeffrey, 2026](#)]), Bloomberg Philanthropies, the Rockefeller Foundation, the Andy Warhol Foundation for the Visual Arts, the New York Community Trust, the New York State Council on the Arts, and the NYC Department of Cultural Affairs [[Creative Time, 2026a](#)]. The named-grant and contributions/earned-revenue detail is itemized on Schedule A / Schedule B of each filing.

## 7. FOOTPRINT

Creative Time’s footprint is civic and temporary: the work is sited in shared space — the harbor, the beach, the subway, a derelict sugar refinery, the sky — and most of it no longer physically exists. The institutional memory lives in three durable forms: (a) the 350+ commissioned projects in the public record; (b) the **Creative Time Records at NYU’s Fales Library** (MSS.179) — 238.58 linear feet spanning 1974–2012 with materials continuing from 2020, including 43.3 GB of digital media [[NYU Fales Library and Special Collections, 2026](#)]; and (c) the recurring Creative Time Summit’s circulation across host cities. Sustained institutional partners across the history include the Lower Manhattan Cultural Council, MTA Arts for Transit, Lincoln Center, The Kitchen, and the NYC Department of Cultural Affairs [[NYU Fales Library and Special Collections, 2026](#)].

## 9. WHAT THIS DOSSIER IS NOT

- **Not a thesis.** There is no question being answered; the dossier surfaces the public record.
- **Not a critique.** Disclosure, silence, and the source disagreements are observed, not judged.
- **Resolved since the scaffold.** The 1973-vs-1974 founding-year question (now read as establishment vs. first public project, *Crafts in Action*, 1974) and the 2015–2018 executive succession (Hollander acting 2015, ED 2016–17, interim, Ludwig 2018) are filled and sourced inline.
- **Not exhaustive.** Remaining locatable gaps left to the companion data folder (papers/arxiv-creative-time/data/): the *full* Form 990 Part VII roster (30+ individuals; only Chair, Treasurer, and ED surfaced here); the Schedule B contributor / named-grant inventory; the complete 350+ project list; and pre-2010 financials (scanned-PDF only, back to 2001).
